3. Per-bid meeting shall be held at **Dewanganj Rural Municipality Office, Dewanganj, Sunsari, Province – 1, Nepal, at 2:00 PM on 20th day of publication of notice.**
4. Electronic bids must be submitted to the office Dewanganj Rural Municipality, Dewanganj, Sunsari, Province -1, Nepal through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Noon on 31th day of publication of notice. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders representatives who choose to attend at 2:00 pm on 31st day of publication of notice at the Dewanganj Rural Municipality Office, Dewanganj, Sunsari, Province – 1, Nepal. Bids must be valid for a period of 90(Ninety) days after bid opening for Single / Double Envelope and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting as specified in PPA and PPR which shall be valid for 30 days beyond the validity period of the bid Information to deposit the bid amount in Bank:
