- Electronic bids must be submitted to the office Dewangunj Rural Municipality Office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 31st day of publication of Notice. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM 31st day of publication of notice at the office of Dewangunj Rural Municipality. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting specific in PPA and PPR which shall be valid for 30 days beyond the validity period of the bid .
